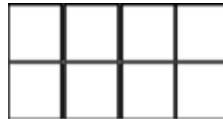

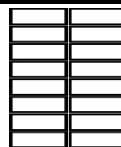

Pallet 80*120



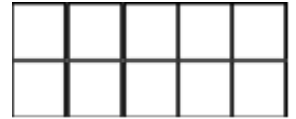
7 layers for pallet

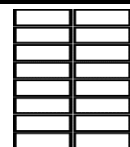
